I am aware that hunting dog activities (where live guns and ammo are used) could be a hazardous activity and I am voluntarily participating or watching these activities with knowledge and appreciation of the danger involved and hereby agree to accept any and all risks of personal property damage, injury, or death.

As **LAWFUL CONSIDERATION** for being permitted to participate in these activities, I agree that I, my heirs, distributes, guardians, legal representatives, and assigns **WILL NOT MAKE A CLAIM AGAINST, SUE, ATTACH THE PROPERTY OF, OR PROSECUTE** the SDSDC, PROPERTY OWNERS, AGENTS AND **AFFILIATED ORGANIZATIONS FOR INJURY TO MY PERSON OR DAMAGE TO MY PROPERTY RESULTING FROM THE PASSIVE OR ACTIVE NEGLIGENCE OR OTHER ACTS, HOWEVER CAUSED**, by an agent, as a result of my participation in any of the activities conducted on the grounds listed above.

I expressly waive any rights I may have under California Civil Code Section 1542, which states: "A general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release, which if known by him or her must have materially affected his or her settlement with the debtor." In addition, I hereby **RELEASE AND DISCHARGE** the SDSDC, PROPERTY OWNERS, **ITS AFFILIATED ORGANIZATIONS, OFFICERS, DIRECTORS, MEMBERS**, from all actions, claims, or demands that I, my heirs, distributes, guardians, legal representatives, or assignees now have or may in the future have for an injury to my person or damage to my property resulting from my participation in sport shooting, hunting, or dog tests organized by the SDSDC.

Further, I hereby agree to **COMPENSATE OR REIMBURSE** THE SDSDC, property owners, affiliates, members of any organization for any claims brought against them for the property damage or personal injury or death which arise as a result of my passive or active negligence or other act(s) while participating in the activities in which I am involved.

I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND CONTRACT BETWEEN MYSELF, LAND OWNERS AND ANY OTHER ORGANIZATION AFFILIATED WITH THIS EVENT.
